DANIEL H. BROWN, is Assistant Professor of Spanish in the Department of Foreign Languages and Literatures at Western Illinois University. He received his Doctorate in Hispanic Languages and Literatures from UCLA in 2010. His research interests include 18th and 19th-century Spanish literature.

Sus áreas de interés académico son la literatura latinoamericana del siglo XIX y XX, el Siglo de Oro español y la teoría crítica. She has been Counselor to the Sub-Secretary for Intercultural Dialogue at the Department of Education in Ecuador. She has worked for the process of Indigenous Bilingual Intercultural Education of Ecuador and the Andean countries. A consultant for national and international organizations, she has given more than 200 talks in Ecuador and around the world. She is the author of *Un universo femenino en el mundo andino* (Quito: Instituto para el Desarrollo Social y de las Investigaciones Científicas, 1999) and coauthor of *La reciprocidad en el mundo andino: el caso del pueblo de Otavalo* (Quito, Ecuador: Abya Yala, ILDIS-FES, 2004). She has also published *Diccionario español-quichua* (Quito, Ecuador: "Tupac" Producciones Didácticas, 1993). Her research, writing and teaching range from topics of the Andean understanding of the cosmos, gender from the Andean perspective, and Andean alternative economies. She is currently writing about the different meanings of being an Indigenous woman today, which this essay is part from.
